# PRESIDENT'S MESSAGE

Dear Solid Waste Professionals,

ILCSWMA is committed to providing our members and others across the state with information on the new Consumer Electronics Recycling Act (CERA). We have been actively reaching out to those across Illinois to focus attention on this matter.

CERA requires county's that would like to participate in manufacturer -supported electronics recycling programs in 2019 to opt-in by March 1, 2018. CERA requires the manufacturers of electronics to support collection of covered electronic devices (CEDs) in counties that opt-in. Many implementation details are still in the development phase.

ILCSWMA held a free webinar for members and non-members on January 31 to raise awareness of the CERA requirements, including the need to opt-in.

ILCSWMA has posted the webinar presentation and supporting materials on our website. In addition, we have been collecting questions about CERA from county governments, in hopes that we will get CTA (the

electronics trade association responsible for implementing the law) to answer them. We will then share the answers for everyone's benefit.

#### **2018 MINI-GRANTS AVAILABLE**

The ILCSWMA Board of Directors reminds members of the availability of two mini-grants, worth up to \$1,250 each, for full member (government) organizations. The objective of this grant program is to stimulate the collection and landfill diversion of any of the following post-consumer materials:

- Food Waste;
- HHW;
- Paint;
- Mercury- Containing Devices;
- Carpet;
- Pharmaceuticals.

Fundable projects must include collection (permanent or one-time) of one or more of these aforementioned materials. Applications are **due by April 30, 2018** and information is posted on the "Documents" page of the <a href="LLCSWMA website">LLCSWMA website</a>.

#### **INDUSTRY NEWS**

#### **EPA GRANTS AVAILABLE**

USEPA announced that up to \$3 million in funding for locally-focused environmental education (EE) grants is available. EPA will award three to four grants in each of EPA's ten Regions, for no less than \$50,000 and no more than \$100,000 each, for a total of 30-35 grants nationwide. Proposals are due March 15, 2018. The Requests for Proposals has been posted on <a href="https://www.grants.gov">www.grants.gov</a>.

In addition to other environmental topics, the 2018 EE Local Grant Program includes support for projects that reflect the intersection of environmental issues and agricultural best-practices, conservation of natural resources, food waste management, and natural disaster

preparedness.

Since 1992, EPA has distributed between \$2 million and \$3.5 million in annual grant funding under this program, supporting more than 3,700 grants.

#### **MEMBER NEWS**

#### **MACON COUNTY**

A used clothing donation bin was painted up and signed for the 24/7 collection of Christmas lights at an unmanned Decatur site. Concerns of contamination and loss proved to be unwarranted as only strings of Christmas lights were emptied from the bin and no signs of misuse were found during routine checks.

#### **OGLE COUNTY**

Ogle County Solid Waste Management
Department (OCSWMD) kept a busy holiday
schedule with the annual Christmas tree
collection and the holiday light collection drive as
well as a cold, but busy, monthly electronics
recycling event held on December 29, 2017.

The OCSWMD continues to offer a monthly residential electronics collection with materials

being sent to Dynamic Recycling in Onalaska, WI. In 2017, this program had 2,560 vehicles pass through, which is an increase from 2,400 vehicles in 2016. All residential electronics included in the landfill ban, as well as a variety of other electronic items, are accepted. In 2017, around 1,900 CRT televisions and 350 CRT monitors were collected from county residents, and, overall, 314,000 pounds of electronics were collected. This program will be continued for 2018 and research has already begun on how to adapt for programyear 2019 and beyond, as the Consumer Electronics Recycling Act kicks in.

Along with electronics recycling, OCSWMD conducts a holiday light drive around Ogle County, beginning prior to Thanksgiving and running throughout January. Collection boxes are stationed at local village halls and fire departments and collected holiday lights are sent to Dynamic Recycling to be shredded and recycled. Dynamic credits the OCSWMD for the material and a donation is made to the local United Way with the proceeds. In 2017 there were 1,180 pounds of lights recycled with \$330 sent to the local United Way for charitable causes in the area.

Numbers are still coming in for the annual Christmas tree collection as well. Residents drop off trees at various points, and on Jan. 6th local high school FFA volunteers picked up trees and brought them in for chipping. The resulting mulch is used by various groups and homeowners for a multitude of projects.
